Backfill for excavation made within the road right of way must be compacted with a vibrator or puddled at one foot intervals. Upon completion of backfill, the excavation area will be mounded up and allowed to settle for a period of one week, during which time the owner is responsible for maintaining the fill above street level. After sufficient time has elapsed to insure proper compaction, the excavation must be dug out and the road surface restored with the same material of the same thickness. In the event the road surface is more than three inches thick it will be necessary to reconstitute the road surface by two applications of the surface material. In the event it is necessary to close the street to traffic, prior to closing the street, the applicant must notify the Woodstock Emergency Communications dispatcher of the necessity to close the street and obtain the Chief of Fire Department's concurrence. Street closing will not exceed four hours without written permission from the Municipal Manager. Detours will be maintained during the time the road is closed.
