## I. CALL TO ORDER

## IV. REQUESTS FOR PERMITS

## a) Use of the Green

## 1) Puppy & Pooches on Parade (August 25<sup>th</sup>)

Ms. Peggy Fraser, representing the Friends of the NWPL, presented the application. She stated this will be the 4<sup>th</sup> year for this event and that there are no changes anticipated this year.

**MOTION** by Ms. Cole to approve the Puppies and Pooches on Parade event on the Green, Saturday, August 25, 2018, from 9:00AM to 1:00PM.

## 2) Lobsters on the Green (July 7<sup>th</sup>)

Ms. Elizabeth Finlayson, Director of the Woodstock Area Chamber of Commerce, presented the 3<sup>rd</sup> Annual Lobsters on the Green event.

Ms. Sally Garmon stated that there is a conflict with the St. James Fair.

**MOTION** by Ms. Cole to approve the Lobsters on the Green event, as presented for either July 7, 2018 or July 14, 2018, leaving the finalizing of the date and logistics to the Woodstock Chamber of Commerce and organizers of St. James Fair.

## 3) Amendment to Maple Madness (March 24th)

Ms. Finlayson is asking to amend the Maple Madness permit for a farm animal 'walk about' parade in conjunction with Billings Farm. Permission was requested to allow for the animals to be placed on the Green weather permitting.

**MOTION** by Ms. Cole to approve the amendment the Maple Madness event permit to allow for a parade of farm animals around the Green and for the allowance of the farm animals on the Green, provided that prior permission is granted by the Municipal Manager based on weather and that clean up after the event will be the responsibility of the Chamber.

**DISCUSSION** Ms. Nelson asked how much of the Green would be used for the animals.

Ms. Finlayson stated towards the mid-point of the Green, however the plan B would be to place the animals on Court Street for children to pet.

Ms. Finlayson stated she would like to propose an amendment to the sale to reflect the Friday and Saturday the weekend after Labor Day, September 7 & 8, 2018.

#### V. POLICE CHIEF'S REPORT

Chief Blish presented his report to the Board:

- He updated the Board on the Governor Highway Safety Border to Border program.
- Cpl. Jim Otranto is back working part time.
- Chief is attending a training program regarding drugs and youth.
- Coffee with the Chief will be held March 9<sup>th</sup> 8AM at Maplefields.
- Community based learning program with high school students has been enacted to get youth involved with public safety and law enforcement.
- Meter warranty options were discussed with the Board.

MOTION by Ms. Cole to approve the Certification of Standards, Roads and Bridges. SECONDED Ms. Nelson DISCUSSION None VOTE 4-0-0, Passed.

## c) Review Employee Parking Program

Chairman Kahn suggested that the Employee Parking permits be issued for Monday – Friday in the Employee Parking area and those spots be open for meter parking on Saturday and Sunday. Mr. Goodenough stated he has heard from residents about the Employee Parking Lot and the number of empty spaces on Saturdays and Holiday weekends in the Lot.

Ms. Nelson shared her experience with parking on Mechanic Street and seeing empty spaces in the Employee Parking Lot.

Mr. Goodenough suggested further discussion of this item at their April 20, 2018, meeting to offer the public a chance to attend.

Ms. Cole proposed a sticker for Village residents to allow for parking longer than 2 hours in the 2 hour non-metered parking on Elm Street.

This item **TABLED** until the April 20, 2018, meeting.

## d) Discussion of Parking Meter Warranty

This item was discussed under item **V. Police Chief's Report**.

- e) Revision #2 to Woodstock Village Ordinances (W.V.O.)
  - 1) Title 8; Traffic, Vehicles & Parking; Chapter 1, Definitions
  - 2) RESOLUTION #2-
    - A. Lengthens to Fifteen Minute maximum the spaces in front of the Post Office.
    - B. Establishes \$1.00 per hour for parking at a meter throughout the Village
  - 3) §8337. Authority to Immobilize a Motor Vehicle for Habitual Violation of the Village Parking Regulations (NEW)

Mr. Swanson gave the summary for the increase of time at the Post Office meters from twelve to fifteen minutes, the proposed Ordinance §8337 to allow for an Immobilization Device and the definition of the Device and the establishment of uniform parking costs and times

Ms. Finlayson inquired as to how to get the Immobilization Device off the vehicle. Chief Blish stated that the offender would have to go to the Police Department to make arrangements for payment of outstanding violations.

Ms. Mary Riley informed the Board that her recent experience took 18 minutes to make a purchase. She would like to advocate for 20 minutes.

MOTION by Mr. Goodenough to approve Woodstock Village Ordinance, Title 8; Traffic, Vehicles & Parking; Chapter 1, Definitions, RESOLUTION #2, A. <u>Time Limits within Metered Parking Zone</u>, to approve the addition of § 8337. <u>Authority to Immobilize a Motor Vehicle for Habitual Violation of the Village Parking Regulations</u> and Parking RESOLUTION #3- <u>Parking Regulations-Employee Parking Lot on Mechanic Street</u> to include, "Permit Holders that also utilize the authorized overnight parking section, as set forth above, must move their vehicle within twelve hours after a snow event to facilitate snow removal. Violators are subject to being ticketed and towed." **SECONDED** by Ms. Nelson

**DISCUSSION** Ms. Finlayson stated that the employees of the Welcome Center and Village may find the increase to a \$1.00 per hour meter parking a hardship.

Chairman Kahn stated the meter increase reflect the newer meter costs which have to be made revenue neutral. **VOTE** 4-0-0, Passed.

## f) Village Ordinance Revision-"Property Given in Lieu of Taxes"

Mr. Swanson stated that the Boards had approved the change of investments, recommended by the Investment Advisory Group for the Rockefeller Endowment fund. The proposed Revision now includes these changes.

**MOTION** by Ms. Cole to accept the Revision #3; §11101; Property Given in Lieu of Taxes and the Statement of Investment Objectives and Policy Town Village 2018, as presented.

SECONDED by Ms. Nelson
