

APPENDIX C (To Title 8 W.V.O.)

Metered Parking Zones

(A) The northerly side of Central Street beginning in front of a property known as 28 Central Street and extending westerly to Elm Street;

(B) The southerly side of Central Street beginning in front of a property known as 79 Central Street westerly to the easterly terminus of the street known as The Green;

(C) The easterly side of Elm Street from Central Street northerly to the southerly boundary of the property known as 29 Elm St.

(D) The westerly side of Elm Street from property located at 6 Elm Street northerly to the Dana House at 26 Elm St.

(E) The northerly side of the street named The Green from Elm Street westerly to Mountain Avenue;

(F) The southerly side of The Green, along the fence, from the easterly end of the Village Green to the westerly end of the Village Green;

(G) The northerly side of The Green, along the fence, from the easterly end of the Village Green to the westerly end of the Village Green;

(H) The southerly side of the street named The Green from the westerly terminus of Central Street westerly to Court Street;

(I) The easterly side of Mechanic Street from the southerly boundary of the Blacksmith Shop property, so-called, southerly to the footbridge crossing the Kedron Brook;

(J) The parking metered portion of the parking area owned by the Village, situated west of Mechanic Street and the 20 parking metered spaces in the Norman Williams Public Library Lot being leased by the Village. Specifically excluding the section of the Mechanic Street parking lot that is designated for employee parking with parking being paid for by purchasing a long term parking permit.

History:

2004 Amendment. Appendix D was repealed by section 7 of Woodstock Village Ordinance Revision #22, adopted by the Board on September 27, 2004, final as of November 26, 2004, and effective June 1, 2005. Revision note: Appendix previously provided a twelve minute metered parking zone covering, “[t]hat portion of the ‘parking meter zone’ as defined and set forth in W.V.O. §8101(23) (A) which is located easterly of the private driveway located westerly of the U.S. Post Office building.”

Revision # 16, 2016 Amendment repealed suggested meter limits on allowable time to park at a meter with time purchased by coin or credit card; except in the twelve minute metered parking zone.

Revision # 16, 2016 Amendment adopts the twelve minute metered parking zone in front of the Post Office, in that portion of the parking meter zone defined in W.V.O. section 8101 (23)(A) which is located east of the private driveway located westerly of the U.S. Post Office Building.

History:

2004 Amendment. Appendix C-1 was added by section 4 of Woodstock Village Ordinance Revision #17, adopted by the Board on November 24, 2003, effective January 23, 2004.

2016 Amendment repealed the four hour suggested meter parking. All meters do not have time limits, except the meters in the twelve minute parking meter zone located in front of the Post Office Building.
