1. The petitioner does hereby waive, release and discharge the Town of Woodstock from any liability incurred or any damage or claim of damage of any kind or nature which he or

others has or may claim to have now or in the future in connection with this work to be done.

2. No work shall be done under this permit until the petitioner to whom it is granted shall have communicated with and received instruction from the Municipal Manger.
3. All the work herein contemplated shall be done under the supervision and to the satisfaction of corrected, the Municipal Manager or his authorized agent which after due notice, is not satisfactorily corrected, the Municipal Manger may, with or without notice, make or cause to be made such corrections and the petitioner shall reimburse the Town for any expense incurred in making said corrections.
4. Drive to be constructed in so far as possible with Vermont Department of Highway Stand Sheet B-71 Profile and Notes.
5. Particular attention shall be made to construct drives so water does not turn onto highways.
6. Maintenance of said drive and culvert shall be responsibility of the petitioner.
7. This permit may be modified or revoked at any time by the Select Board of the Town of Woodstock, Vermont.
8. It is the responsibility of the property owner to maintain the culver and keep it clear and free of gravel and other debris.
9. Establish and maintain 20 feet negative slope of ¼" per foot from road prior to beginning climb to house site.
10. Applicant does hereby agree to hold the Town of Woodstock harmless form claims of all third parties for damages from whatsoever cause incident to the exercise of this permission to construct a driveway.
