q. Chair Riley stated that there are some elected positions that the Select Board will have to appoint. They will look at those at the later March meeting. Last year many did not get filled due to Covid. Once they get the official return of vote from Charlie Degener, they will know which positions they need to fill.

Motion: by Ms. Cole to reappoint David Green as Fire Warden and Health Officer, Emo Chynoweth as Deputy Fire Warden, Don Wheeler as Tree Warden, Fred Barr as Inspector of Lumber and Fence Viewer, William Kerbin as Delinquent Tax Collector and Greater Upper Valley Solid Waste Management District Representative, Glenn Soule for South Woodstock Design Review Board, Kim French for the Development Review Board, Byron Quinn, Barbara Gibbs, and Bethany Powers for the Conservation Commission, Sam Segal and Sara Stadler for the Planning Commission, Richard Roy and Joseph Lucot for Fence Viewers, Joe DiNatale and Mica Seely to the Economic Development Commission, and to appoint Joseph Swanson as Truant Officer and Brad Prescott as Two Rivers Ottauquechee Regional Commission Representative.

Discussion: Chair Riley stated that most of these appointments rare one-year terms.

Ms. Marrinan congratulated Mr. Swanson and Mr. Bourgeois to the Select Board. She asked about the requirements for Auditors or Trustee of Public Funds.

Chair Riley stated that Mr. Degener has the requirements. Most years a person must circulate a petition to run. Some people do not want to do that or do not have the time. None of that was the case this year. Terms of office for those positions rotate. Anyone is welcome to check in to the Clerk's Office to see what positions are still available and what the requirements are.

2. Resolution for weight restriction on Town Highways

a. Chair Riley stated that this resolution is for the roads that are posted in the spring. The Select Board has a policy that they can restrict overweight truck from going on these roads while the roads are soft. They post signs at the bottom of the roads. They do this every year. The Highway Supervisor must post the policy once it is approved and signed.

Motion: by Ms. Cole to approve the resolution for Weight Restrictions on Town Highways.

1. Mr. Doten welcomed Mr. Swanson and Mr. Bourgeois to the Select Board.
