Dear Woodstock Select Board:

I wanted to bring to your attention a very concerning situation involving clients of mine, Dan and Meridith Peirce, who recently purchased a 9.85 acre parcel on Rabbit Hill Way (Parcel 04.02.03.001). My clients have engaged Chris Ambrose to build a tasteful, high-quality single family residence on the property for my clients' personal family use. All state subdivision and local zoning permits have been obtained as part of the development and my clients' engineer is currently obtaining the state stormwater discharge permit.

Unfortunately, my clients have received the attached correspondence from Mary Margaret Sloan, Vice Chair of the Woodstock Planning Commission, and Howard Krum, a member of the Woodstock Conservation Commission. The correspondence contains many false statements including those related to "massive clearcutting," proximity to the Marsh Billings Park (subject parcel is acres away from same), violation of town ordinances, "killing thousands of animals and plants," soil erosion and degradation to Gulf Stream (again, the parcel does not even abut the Gulf Stream), Act 250 jurisdiction (there is none), etc.

We understand that Ms. Sloan and Mr. Krum may have personal concerns about the development of a home in their viewshed, but the development is fully permitted and is being completed with all due care and diligence. If they were so concerned about the development, then they should have objected to the town zoning permit approval.

What Ms. Sloan and Mr. Krum are doing now is abusing their power as members of town boards to bully and intimidate my clients into ceasing their home building project. Such actions constitute a massive conflict of interest and can bring substantial liability to the town, especially since they've clearly included their public position status in their correspondence and have made flagrantly false statements.

We would hope the Town Select Board would intervene here to stop this bullying abuse of power as soon as possible and let my clients continue contributing to Woodstock's local economy with their project and then enjoy their new home with their family.

Dear Mr. and Mrs. Peirce,

My wife (Mary Margaret, vice chair of the Woodstock planning commission) and I (a member of the Town conservation commission) own Gilbert's Hill farm on Barnard Road — we are informally reaching out to you on behalf of a number of concerned Woodstock residents.

We are writing to make you aware of a serious and problematic situation involving your property on Rabbit Hill Way: You likely do not know that your contractors recently clearcut (to bare earth) an enormous section of the hillside just below the Marsh-Billings-Rockefeller National Historical Park — it is our understanding that this was likely performed in violation of Town ordinance(s). Then, shortly after the clearcutting which killed thousands of animals and plants, excavation of a massive construction pit began in very steep terrain (~18% slope), no doubt promoting soil erosion into and environmental degradation of the protected Gulf Stream below. This stream and your land are in the Aqueduct watershed that supplies drinking water for the Town. It has long been a local understanding that this land on Rabbit Hill Way is not legally buildable due to the excessive grade of the access road(s) for police, fire and emergency vehicles. And, it is unclear whether the development of this subdivision has been approved through the State's Act 250 process.

We'd like to propose two potential alternatives to this devastating situation: 1) halt construction and either allow the land to naturally regenerate or donate the property to the Vermont Land Trust (you will receive a generous tax deduction and become heroes to all); or, 2) if you pursue construction (assuming you can acquire all the proper State and local permits), devise a way to effectively screen the resulting structures and lighting from view, clad all exterior surfaces with dark/muted materials, use non-reflective glazing, and totally replant the destroyed hillside.

Gilbert's Hill and its surrounding protected acreage is on the National Register of Historic Places and is a valued public resource attracting visitors to Woodstock from around the world. Over 200 individuals and organizations came together to preserve this landmark for the benefit and use of all. Other neighbors, representatives of the National Park Service, the interim Town Manager and staff in the Woodstock planning and zoning office are examining the issues presented by the project on Rabbit Hill Way. But, now that you are aware of the numerous associated problems, we hope that you will quickly come to a generally-acceptable solution to avoid further environmental and scenic destruction.

If you would be so kind, please let us know how you plan to proceed — we would be more than happy to help chart a positive course forward. In fact, we'd like to have you over to Gilbert's Hill the next time you are in the area.

Dear Dan and Meridith,

Many thanks for your response. Unfortunately, the furor over your massive clearcutting operation on Rabbit Hill Way has only grown over the last several days. Outraged folks have reported the project to multiple State and local officials and there has even been talk of a potential news story. Here is an excerpted quote from a respected neighbor:

"I've been horrified by the unfolding destruction to the hillside... This project is a reckless gaping wound on the side of the hill..." You should note that this resident of Woodstock (and others) reported your project as an environmental violation to the Vermont Agency of Natural Resources.

At this point we remain heartbroken over what has happened. We hope that you can appreciate the sad irony of the situation: you wish to move here because of Woodstock's natural beauty but are destroying it in the process (and this destruction is just few steps from the national monument commemorating the launch of the American conservation movement). We created (and ultimately control) the view you are exploiting while at the same time you are ruining the scenic and natural beauty for us, our neighbors, and all who visit our protected land. In fact, our property is preserved by multiple easements to prevent just the kind of destructive development you are causing (and the 200+ individuals and groups that came together to save Gilbert's Hill have yet to be enlisted for this issue). We have a close-knit, caring, intelligent and determined cohort of neighbors. Unless you act decisively to change the trajectory of this project we don't see how you can salvage your reputation in this Town.

You state an interest "in being responsible members of the community and good stewards of the land." To be clear: massive clearcutting of a forest to bare earth (with no erosion control and killing countless animals and plants in the process) is modern-day environmental abuse that is broadly condemned. We understand your desire to live harmoniously in this community but Vermonters judge outsiders by their behaviors not their words — your actions to date do not bode well for your reception.

We're not anti-development. We understand that Woodstock will attract newcomers wanting to build homes here and we welcome responsible construction. However, Woodstock residents expect that the nature of such development will respect the rural character of this special place rather than raze it. Please meet us half way here and share the specific and detailed measures (structure screening, lighting plans, replanting efforts, etc, etc) that you will commit to using to help mitigate this environmental and scenic destruction to the Prosper Valley.

It is our hope that we can have a happy, neighborly relationship once we are able to call Woodstock our home! We are among those who have long admired the beauty of your property and we appreciate its significance to the town and beyond. We would love to take you up on the offer to visit you at Gilbert's Hill when we are next in town.

Dear Dan and Meridith,

I will, of course, respect your decision not to talk with us to chart a positive course forward. We do appreciate the sentiment you've expressed of "keeping our concerns in mind," unfortunately, this is simply not an adequate response to the scenic and environmental damage you are causing in Woodstock. 0 Rabbit Hill Way might be your property to bulldoze but Woodstock is our home and community to protect. If it is true (as you state) that you wish to build a neighborly relationship, then we ask you to fully commit to the mitigation roadmap we've laid out below. These measures were derived from guidelines recently developed by the Two Rivers-Ottauquechee Regional Commission, as well as the Vermont Climate Action Plan. The minimum required actions necessary to yield a tolerable outcome for us, our neighbors, and the greater Woodstock community fall into three categories —

- 1. Deforestation: Replant the entire area you've deforested (which was clearcut and razed to bare earth) to within 25' of any structure, on all sides. This reforestation project needs to replace the same species you removed at the same density as the surrounding forest and the new trees must be allowed/encouraged to reach full maturation and canopy height. In addition to the loss of forest habitat for wild animals and plants, by clear-cutting you have contributed to climate change by destroying the forest canopy, reducing biomass and decreasing carbon sequestration. As a Prosper Valley resident recently noted about you, "I'm curious how they justify their commitment to deforestation..."
- 2. Erosion: The clearcutting and earth disruption you've performed without erosion control has caused the VT Agency of Natural Resources to issue a stop-work order for your project, you

obviously need to address their concerns and furthermore you need to ensure that only porous substrates are used for any driveways or patio areas, etc. In these times of both severe drought and cyclical deluge, we can't afford to degrade/damage/stress our streams and groundwater resources further.

3. Scenic destruction: The damage you have done to Woodstock's scenic resources, only steps from the Marsh-Billings-Rockefeller National Park, is devastating. As such, the exterior surfaces of all structures you construct must be clad in muted, dark materials/colors, all windows should be tinted to restrict the escape of interior light pollution, and the exterior window glazings should be non-reflective. Exterior lighting should be minimized and, of course, only directed downward. The overall goal is to help make your structure less obtrusive by blending (as much as possible) into the natural surrounds.

Though you may "bristle" at this prescribed roadmap, please consider these mitigation measures seriously because scenic and natural beauty as well as a healthy environment are key to Vermont's future and economy — a voluntary commitment to these specific actions is in your very best interest. However, if we don't hear back from you by COB on 08/26/22 we will understand that you are rejecting these minimum mitigation actions and we will proceed accordingly.

The good news in this unfortunate situation is that the trajectory of this rapidly-escalating issue is entirely within your control — we are begging you to <u>act</u> responsibly.

(Cite as: 24 V.S.A. § 872)

§ 872. Selectboard; general powers and duties

- (a) The selectboard shall have the general supervision of the affairs of the town and shall cause to be performed all duties required of towns and town school districts not committed by law to the care of any particular officer.
- (b) The selectboard shall annually, on or before July 31, acknowledge receipt of and review the document made available by the Auditor of Accounts pursuant to 32 V.S.A. § 163(11) regarding internal financial controls and which has been completed and provided to the selectboard by the treasurer pursuant to section 1571 of this title.
- (c) The selectboard may require any other officer or employee of the town who has the authority to receive or disburse town funds to complete and provide to the selectboard a copy of the document made available by the Auditor of Accounts pursuant to 32 V.S.A. § 163(11). The officer or employee shall complete and provide the document to the selectboard within 30 days of the selectboard's requirement. The selectboard shall acknowledge receipt of and review the completed document within 30 days of receiving it from the officer or employee. (Amended 2011, No. 155 (Adj. Sess.), § 26.)

Article 1. Authority. Under the authority granted in 24 V.S.A. § 2291(20), the Town of Woodstock Select Board hereby adopts the following policy concerning conflicts of interest.

Article 2. Purpose. The purpose of this policy is to ensure that the business of this municipality will be conducted in such a way that no public officer of the municipality will gain a personal or financial advantage from his or her work for the municipality and so that the public trust in municipal officials will be preserved. It is also the intent of this policy to ensure that all decisions made by municipal officials are based on the best interest of the community at large.

Article 3. Application. This policy applies to all public officers as that term is defined below.

Article 4. Definitions. For the purposes of this policy, the following definitions shall apply:

A. Conflict of interest means any of the following:

- 1. A direct or indirect personal or financial interest of a public officer, his or her spouse, household member, child, stepchild, parent, grandparent, grandchild, sibling, aunt or uncle, brother- or sister-in-law, business associate, or employer or employee in the outcome of a cause, proceeding, application, or any other matter pending before the officer or before the public body in which he or she holds office or is employed.
- 2. A situation where a public officer has publicly displayed a prejudgment of the merits of a particular quasijudicial proceeding. This shall not apply to a member's particular political views or general opinion on a given issue.
- 3. A situation where a public officer has not disclosed ex parte communications with a party in a quasijudicial proceeding.

A "conflict of interest" does not arise in the case of votes or decisions on matters in which the public official has a personal or financial interest in the outcome, such as in the establishment of a tax rate that is no greater than that of other persons generally affected by the decision.

- B. Emergency means an imminent threat or peril to the public health, safety, or welfare.
- C. Ex Parte Communication means direct or indirect communication between a member of a public body and any party, party's representative, party's counsel or any person interested in the outcome of a quasi-judicial proceeding, that occurs outside the proceeding and concerns the substance or merits of the proceeding.
- D. Official act or action means any legislative, administrative, or quasi-judicial act performed by any public officer while acting on behalf of the municipality.
- E. Public body means any board, council, commission, or committee of the municipality.

- F. **Public interest** means an interest of the community as a whole, conferred generally upon all residents of the municipality.
- G. Public officer means a person elected or statutorily-appointed to perform executive, administrative, legislative, or quasi-judicial functions for the municipality. This term does not include any municipal employee.
- H. Quasi-judicial proceeding means a case in which the legal rights of one or more persons who are granted party status are adjudicated, which is conducted in such a way that all parties have opportunities to present evidence and to cross-examine witnesses presented by other parties, and which results in a written decision, the result of which is appealable by a party to a higher authority.

Article 5. Prohibited Conduct.

- A. A public officer shall not participate in any official action if he or she has a conflict of interest in the matter under consideration.
- B. A public officer shall not personally or through any member of his or her household, business associate, employer or employee represent, appear for, or negotiate in a private capacity on behalf of any person or organization in a cause, proceeding, application, or other matter pending before the public body in which the public officer holds office.
- C. A public officer shall not accept gifts or other offerings for personal gain by virtue of his or her public office that are not available to the public in general.
- D. A public officer shall not use resources unavailable to the general public including but not limited to municipal staff time, equipment, supplies, or facilities for private gain or personal purposes.
- Article 6. Disclosure. A public officer who has reason to believe that he or she has or may have a conflict of interest in a particular matter shall, prior to participating in any official action on the matter, publicly disclose at a public meeting or public hearing that he or she has an actual or perceived conflict of interest in the matter under consideration and disclose the nature of the actual or perceived conflict of interest. Alternatively, a public officer may request that another public officer recuse him or herself from a matter due to a conflict of interest. ¹
- Article 7. Consideration of Recusal. Once there has been a disclosure of an actual or perceived conflict of interest, other public officers may be afforded an opportunity to ask questions or make comments about the situation. If a previously unknown conflict is discovered during a meeting or hearing conducted by a public body of the municipality, the public body may take evidence pertaining to the conflict and, if appropriate, adjourn to an executive session to address the conflict.

¹ Such request shall not be considered an order for the officer to recuse him or herself.

Article 8. Recusal.

- A. Recusal of Elected Officers. After taking the actions listed in Articles 6 and 7, an elected public officer should declare whether he or she will recuse him or herself and explain the basis for that decision. If the public officer has an actual or perceived conflict of interest but believes that he or she is able to act fairly, objectively, and in the public interest, in spite of the conflict, he or she shall state why he or she believes that he or she is able to act in the matter fairly, objectively, and in the public interest.²
- B. Recusal of Appointed Officers. The failure of an appointed public officer to recuse himself or herself in spite of a conflict of interest may be grounds for discipline or removal from office.³

Article 9. Post-Recusal Procedure.

- A. A public officer who has recused himself or herself from serving on a public body in a particular proceeding shall not sit with the public body, deliberate with the public body, or participate in that proceeding as a member of the public body in any capacity, though such member may still participate as a member of the public.
- B. The public body may adjourn the proceedings to a time certain if, after a recusal, it may not be possible to take action through the concurrence of a majority of the total membership of the public body. The public body may then resume the proceeding with sufficient members present.

Article 10. Enforcement.

- A. Enforcement Against Elected Officers; Progressive Consequences for Failure to Follow the Conflict of Interest Procedures. In cases where an elected public officer has engaged in any of the prohibited conduct listed in Article 5, or has not followed the conflict of interest procedures in Articles 6 through 9, the Town of Woodstock may take progressive action to discipline such elected officer as follows:
 - 1. The chair of the Town of Woodstock Select Board may meet informally with the public officer to discuss the possible conflict of interest violation. This shall not take place in situations where the chair and the public officer together constitute a quorum of a public body.
 - 2. The Town of Woodstock Select Board may meet to discuss the conduct of the public officer. Executive session may be used for such discussion in accordance with 1 V.S.A. § 313(a)(4). The public officer may request that this meeting occur in public. If appropriate, the Town of Woodstock may admonish the offending public officer in private.

Each member of an elected public body is independently elected and answers only to the voters. Therefore, unless there is a local ordinance or charter provision that states otherwise, the remaining members of the body may not force recusal. They may only express their opinion about the subject and/or privately or publicly admonish a fellow member who fails to handle conflicts appropriately.

Certain appointed officials such as a Zoning Administrator and a Town Manager may only be removed for cause and after being afforded with procedural due process protections including notice and a reasonable opportunity to be heard.

3. If the Town of Woodstock Select Board decides that further action is warranted, the Select Board may admonish the offending public officer at an open meeting and reflect this action in the minutes of the meeting. The public officer shall be given the opportunity to respond to the admonishment.

4. Upon majority vote in an open meeting, the Town of Woodstock may request (but not order) that the

offending public officer resign from his or her office.

B. Enforcement Against Appointed Officers. The Town of Woodstock Select Board may choose to follow any of the steps articulated in Article 10A. In addition to or in lieu of any of those steps, the Town of Woodstock Select Board may choose to remove an appointed officer from office, subject to state law.

Article 11. Exception. The recusal provisions of Article 8 shall not apply if the Town of Woodstock Select Board determines that an emergency exists and that actions of the public body otherwise could not take place. In such a case, a public officer who has reason to believe he or she has a conflict of interest shall disclose such conflict as p

5. First Amendment Training


This training occurred on Monday August 8. The Town Officers were closed during the one-hour training.

 - 4. Mr. Cloud stated that he has been the City Manager of Saint Albans for about 15 years. He previously served as the Director of the VLCT Municipal Assistance Center. Since leaving VLCT, he has been involved in half a dozen searches in various roles. He recently participated in the manager searches in Essex and in Shelburne with MRI. He thinks it is important to meet with the Boards and get a sense of what the challenges are that are facing the community, what the opportunities are, and what their vision is for the next manager. They want to make sure they are getting somebody good for the community. The pool of candidates is going to include managers of smaller towns looking to move up, department heads in larger towns that are looking to move up in position. They will have some non-profit department heads and executives and some for-profit folks. The mission-driven folks are generally a better fit than your private sector executive. Sometimes an internal candidate can be great, but they have to have the right skill set. Woodstock is known and presents well on the internet. They can tweak the Town website somewhat. Woodstock is a great community. Somebody's spouse could find rewarding employment as well. It is an easier sell as they look to diversify the applicant pool. They have to have somebody who feels comfortable in the community. They need someone who is good with people. The manager has

to be present in the community. They have to be visible. They do not have to be in the office every single day, but they need to be there most days. They are probably going to want to have some openness to a hybrid model. They want to have a flexible workplace where someone can work remote from time to time. They may find a candidate that is not in a position to move but willing to commute. They want to have this be a confidential process until extremely late in the process. They need to have a meeting to come up with a game plan.
