#### 5. TOWN PLAN REVISIONS

The Goal is to have the updated town plan by the beginning of the September meeting. Plan to have the final draft in by October. Potential special meeting exclusive to the town plan second week in September to get it finalized.

# 7. PLANNING & ZONING WEBSITE UPDATES (LAURA & STEVEN)

Ms. Powell presented on way to better meet the needs of town website users. It is currently difficult to navigate. Having a better website would increase transparency in the planning and zoning department. The website should make it more efficient and make it easier for people to apply for permits and to develop in Woodstock. Utilize GIS mapping to create a map to see what district you live in to see what specific regulations you may need to follow. The website should be optimized for hand held use have accessible meeting calendar get user feedback about the website. Mr. Bauer to figure out a budget for future website plans. Starting estimates are appx. 20k for 2023 website budget. Task: create a subcommittee for the website to help keep it flowing. Ms. Powell and Mr. Horneck volunteered to be on the subcommittee.

### 8. RESIDENTIAL BUILDING ENVELOPE / CLEARCUTTING DISCUSSION

Question presented to the Commission: How can we regulate rural clear cutting? Consider steep slopes and visibility from other properties; require new development to plant new trees? Review other zoning regulation's process first and then determine how to best limit.
