A. Call to order

- 1. Chair Swanson called the regularly scheduled select board meeting on December 6, 2022, to order at 10:02 am.

- D. Manager's Report
 - 1. General Report
 - a. Mark Hunter was introduced as the new Public Works director, he started on November 30, 2022.
 - b. Last week the Governor reported about 40 million dollars available for infrastructure projects. Maximum of a million dollars per municipalities. Mr. Hunter and Mr. Yennerell reached out to Hoyle and Tanner to see if they would potentially put together a grant application for us to take advantage of the new funding.
 - c. Lastly, Mr. Yennerell provided a handout on several cuts from the budget he recommends the town make. 360,400\$ of cuts from the budget as proposed, which would make it a 3.5% increase over last year's budget.

E. Old Business

- 1. FY24 Budget
 - a. Ms. Davies and Ms. LeFever continued the FY24 budget discussion with revisions from previous meetings as well as more in depth conversation. They suggested that answers to questions posed be done offline for the sake of the meeting length. Additionally, they discussed ways to improve the budget (key ideas for consideration), impact of improvements, use of one time funds like ARPA and FY22 budget surplus, and finally review the meeting schedule moving forward.

F. New Business

- 1. US Rt 4 Corridor Plan
 - a. Mr. Arcanio stated that a corridor plan is an outreach effort that is implemented ahead of a large roadway reconstruction project. Information such as how the current roadway is preforming, and potential improvements are shared with the public. The project spans from the start of the Class 1 Town Highway in Woodstock to the start of the Class 1 Town Highway in Hartford including 13.4 miles of highway, 3 towns, within District 4, involves the Ottauquechee River, I-89 Entrance / Exit Ramps, and Former rail (in parts). This

reconstruction project is not one for the near future but could be seen starting after the next decade.
