#### A. Call to order

1. Chair McIlroy called the Board of Trustees Meeting of July 11, 2023, to order at 6:30 pm.

# B. Planning Commission Interview – Benjamin Pauly

1. Mr. Pauly expressed his interest in the position and the committee. He has attended meetings in the past including two last week.

### C. Citizen Comment-

- 1.Margaret Fraser announced the Puppies and Poochies event is taking place on August 26<sup>th</sup>. If there are weather issues, it will be moved to the High school.
- 2. Margaret Fraser also commented on Comment on the water situation. Mr. Duffy replied that the Aqueduct is a private company so the municipality could not control their communications. However, he admitted that the municipality does need to improve their communication plan.

# E. Manager's report

1. Mr. Duffy mentioned that the Staff Accountant resigned and the municipality has posted the position and is going to use NEMRC in the short term to ensure all work is completed

- 2. Mr. Duffy met with the Finance Advisory Committee to discuss the FY25 Budget Process
- 3. Reported that the Woodstock Aqueduct is still asking residents to converse water
- 4. Reported that the DPW is busy repairing roads and have had to make priorities in order to fix washed out roads
- 5. Mr. Kahn stated that the Trustees need to decide how to spend the rest of the ARPA funds.

## F. Police Chief's Report

- 1. Chief Swanson said there were 293 traffic stops in July and 21 foot patrols. He has planned a coffee with the Chief at Mon Vert for August 23<sup>rd</sup>. He also talked about improving the graphics of the vehicles and a way to purchase new vehicles as there are two that are from 2015 and 2018.
- 2. Jill Davies asked about help with FEMA for residents. Mr. Duffy said that the municipality is able to offer help but the majority of the work is now with the State and FEMA.
- 3. Lisa Lawlor asked about making sidewalks a priority. Chair McIlroy said that the Trustees are making it a priority. Mr. Kahn said that a lot of work has been done and they are aware of more sidewalks that need to be done.

• Norm Frates spoke about the permit. This is the 18<sup>th</sup> year of the event and nothing has changed. They expect about 1500 people.

## b. Lewis-Healey Wedding Sendoff

• Claudia Rollin spoke about the permit, she is wedding planner for wedding. They are requesting hosting a farewell bunch from 9am-12:30PM on the Green. They are expecting about 100 guests, with food and coffee and 3-4 tables. Jeffrey asked that are they okay with public being around and they agreed. The party would pick up trash themselves. Ms. Davies, Ms. Lawlor, and Ms. Frazer all said that this would create a precedent and that people walk their dogs there. Mr. Corson and Chair McIlroy agreed that this would be a precedent that the Trustees would be setting. After discussion the Trustees agreed that a \$400 fee would be included in the permit to mirror the East End park regulations.
