Proposed Development:

To rebuild a portion of existing stone wall and steps, add a 10' x 10' patio

and improve drainage of yard and driveway.

Ben Pauly explained the retaining wall is failing due to pressure and water is coming through the wall. Randy Mayhew mentioned he lives in the area and has noticed water running across the road at a higher rate than in the past.

Ben Pauly explained water is coming from the backyard. There are french drains along the house that keep the basement dry and this is first year this amount of water has drained down driveway. Ben mentioned the abutting owner across River Street has concerns about the water, so he cut a one-inch channel in the driveway to direct water towards the drain across the road.

Randy Mayhew mentioned the drainage plan may need to go in front of the Village Trustees rather than this board. Steven Bauer replied the application is for Design Review approval. Keri Cole asked if they are just considering the patio and wall design and Steven confirmed yes, the board does not need to consider the drainage issue.

Ben Pauly presented the plan to remove and replace a portion of the stone wall, keep grading the same, replace stone steps with solid slabs and add a brick patio.

Wendy Spector asked if the wall design will impact the drainage issue and Ben Pauly mentioned the curb cut in driveway has helped the water direct towards the drain.

Wendy Spector motioned to close testimony.

Keri Cole seconded the motion.
