### A. V-0006-25 - Zilian, LLC

Location: 26 Central Street

Parcel ID: 20.52.28

Review: Conditional Use and Design Review

Proposed Development: To complete interior and exterior renovations related to

Life Safety and Accessibility code requirements.

Jim Pulver presented the application as the architect for the project. He provided the Board with updated handouts. He mentioned the two meetings with the DAC and Conservation Commission. The project involved creating two retail spaces on the lower level and maintaining the apartment space on the second floor. Jim outlined the need to address code issues, including removing the canopy and post-modernist gable, and creating ADA-compliant access. The decks on the rear of the building will be replaced and the VDRB discussed the design recommendations from the Design Advisory Committee. The staircase leading to the back is in the 100-year floodplain and riparian buffer zone. The staircase will be rebuilt in the exact footprint and anchored to the existing concrete pad. Jim mentioned he will provide the zoning department with the base flood elevation certificate to show the building is above the base flood elevation and the updated plans.
