Conservation Overlay District.

John Harrington begins explaining the existing conditions and the project's scope. The project involves a 1125-foot driveway to access a single-family residence on a 42.5-acre parcel. John Harrington describes the topography of the site, including moderate and steep slopes. The driveway is designed to minimize grading impacts and avoid wetlands as much as possible. Discussion on the placement of culverts to manage water flow and avoid wetlands. John Harrington provides details on the driveway alignment, including emergency pull-offs and grading impacts. The project has received state wetland and water wastewater permits, with a low-risk general construction permit pending. John Harrington shares a drone photograph to help visualize the project area.
